Dear Judge McKenney:

Thank you for granting the City of San Jose's motion to amend the Santee neighborhood injunctions that was scheduled for hearing on December 19, 2013 at 9 a.m. in the matter referenced above.

I understand that Ms. Mary Toller appeared before you on the 19th and expressed some concerns. I subsequently met with Ms. Toller, and all of her concerns are now resolved. She did bring to my attention that a provision contained in the First Modification of the Permanent Injunction issued by the Court in 2010 (Exhibit D to our motion) that calls for the Court to review the 1997 Injunction in January of 2020 (Ex. D, pp. 2:24 – 3:1) is not included in the proposed Amended Injunction. As a result, I have enclosed a revised **[PROPOSED] ORDER GRANTING MOTION TO AMEND INJUNCTIONS** for your consideration and signature that includes a similar provision requiring review of the Amended Injunction in 2020 and an updated description of the procedural history of the motion.

We were unable to serve the motion on the sole property owner for 1424 Carnelian Drive (APN # 477-32-193). As a result, that owner and property remain subject to the earlier injunction. The APN for that property has been deleted from Exhibit A of the Amended Injunction that is enclosed herein for your signature. For your information, we were also unable to serve two of three owners on another property but, since one owner was served, that owner and the property will be subject to the Amended Injunction. We

We were also informed that two co-owners of properties are deceased but, since other owners of the same properties were served, the surviving owners and those properties will also be subject to the Amended Injunction.


