

Important benefits of permits and inspections:

- SAFETY Your project is checked to ensure that it meets building safety standards.
- QUALITY Permits and inspections help assure the quality of your remodeling investment and are important to the value of your property.
- LEGAL They are required by state and local laws. Unless voluntarily corrected, illegally conducted work may incur costs for citations, permits, and reconstruction.

How to Get a Building Permit

If you are planning to improve your property, you may need a building permit. Any change to the structural, electrical, plumbing or mechanical configuration of any part of a home or building requires a permit. Installing certain appliances or equipment, such as a water heater, also requires a permit. Painting, flooring and other cosmetic work don't need a permit. For more information or if you're seeking to legalize work done without a permit, see the bulletins entitled **Projects That Don't Need a Building Permit** or **How to Legalize Unpermitted Work**.

Here are the steps for getting a building permit, including any trade permit for electrical, mechanical or plumbing work:

- STEP 1 Choose the permit service that fits your project. This bulletin describes our permit services and helps you choose the right permit service for your project.
- STEP 2 Complete and submit a Building Permit Application. This form is required except in the case of online permits. The application covers all types of permits—building, electrical, plumbing or mechanical. If other forms are needed, our Permit Center staff will let you know.
- STEP 3 Accurately prepare project plans. Except for online permits, all projects require accurately drawn plans. For some projects, anyone can draw the plans as long as they are accurate, but some project plans must be produced by licensed professionals. Permit Center staff will help you understand what you need to submit, or visit the Building Handouts and Forms web page for helpful information on the content and production of project plans.

ONLINE PERMIT SERVICE Download our lowest-cost permit at www. sjpermits.org. Fast and easy. Limited to simple projects and installations of equipment and major appliances.

OVER-THE-COUNTER SERVICE. Walk in with your accurate plans, walk out with a permit.

For residential projects with no or only minor structural changes.

PLAN REVIEW SERVICE. For projects with structural changes or new construction. Your plans are reviewed by experts for compliance with zoning and codes. On a tight timeframe? The Express or Enhanced Express options provide faster service.

How to use sipermits.org

First register at **sipermits.org**. Be prepared to provide the property address, your email address, and credit card for payment.

Contractors must provide their state license number and City of San José business license number.

The system will guide you as you enter your information and select the desired permit.



Most online permits do not require plans; only a rooftop solar installation requires a plan; it is not submitted but rather reviewed at the time of inspection.

The list of permits that can be obtained online is subject to change; a current list is maintained at sppermits.org.

To use Over-the-Counter Service, come to the Permit Center and bring:

- A completed **Building Permit Application**
- Accurate project plans; they do not have to be professionally drawn, but they <u>must be</u> <u>accurate</u> in order to get the permit issued on the day you visit.
